RESOLUTION:- In furtherance of its policy of decentralization and acceleration of land acquisition proceedings, Government has decided to delegate its powers in respect of withdrawal of lands from acquisition and is, accordingly, pleased to confer on the Commissioners concerned the powers and the functions under the following sections of the Act specified against each:-

Section No.	Name of the Act.	Summary of power/duty	Areas in which the power/duty is conferred on the Commissioner concerned.
Section 48	Land Acquisition Act, 1894(I of 1894) in its application to the Bombay area of the State of Maharashtra.	Power to decide whether to withdraw from the acquisition any land of which possession has not been taken.	Bombay area of the State of Maharashtra.
Section 48	Land Acquisition Act, 1894(I of 1894) in its application to the Vidarbha region of the State of Maharashtra.	- do -	Vidarbha area.
Section 39	Land Acquisition Act, 1309 F(Hyderabad Act, IX of 1309 F).	- do -	Marathwada area.

2. The requisite notification should be published in the Maharashtra Government Gazette.

3. The Settlement Commissioner and Director of Land Records should be requested to issue necessary correction slip to the Manuals of Land Acquisition.
