Government is pleased to sanction the continuance of the staff sanctioned under Government Resolution, Revenue Department No. ICH. 1361/64245-M dated 22nd May 1961, and under Government Resolution, Revenue Department No. ICH. 1661/86207-M(Spl.) dated 11th January 1962 and last continued under Government Resolution, Revenue Department No. ICH 1363/18272-M(Spl.) dated 7th March 1963, for a further period of two months ending 30th June 1963 or till the formation of the Maharashtra State Farming Corporation Ltd, whichever is earlier.

2. Government is also pleased to sanction the continuance of the staff sanctioned under Government Resolution, Revenue Department No. ICH. 1362/91610-M(Spl.) dated 29th November 1962 and last continued upto 30th ~~xxxx~~ April 1963 under Government Resolution, Revenue Department No. ICH 1363/18272 -M(Spl.) dated 7th March 1963 for a further period of two months ending 30th June 1963 or till the formation of the Maharashtra State Farming Corporation Ltd. whichever is earlier.

3. The expenditure in respect of the staff sanctioned in paragraph one above should be debited to the budget head "19 General Administration D Commissioners-DI-Commissioner" and met from the sanctioned grants thereunder during the year 1963-64.

4. As the staff mentioned in paragraph 2 above is required for making preliminary arrangements in respect of the management of the Sugar Factory Farms, Government is pleased to direct that the expenditure incurred on this reestablishment till it is actually transferred to the Government owned company to be established for the management of the Farms should be recovered from the Company after it is set up. The expenditure in respect of this staff should be debited to "19-General Administration-Q-General Establishment-Q1 General Establishment" and met from the grants sanctioned for the year 1963-64.
